Trustees Annual Report and Financial Statements

The principle objects of the charity are to assist in the maintenance of the fabric and grounds of the Church of St. John the Baptist Church Findon, in the Diocese of Chichester, and to preserve and protect this ancient building through fund raising and membership income. The full constitution of "The Friends" can be found at the Friend's website www.fosjbf.org.

During the year we were able to recommence our fund raising activities which were so severely impacted in the two previous financial periods through the Covid pandemic. The success of these is more fully covered in the following chairman's and treasurer's reports, but suffice to say these events contributed significantly to the bolstering of our funds. In our previous report we stated that we were looking forward to organising a car rally at Findon Place, a golf day at Hill Barn and providing the refreshments at the Christmas Tree Festival, held bi-annually in the church. All of these took place in addition to which we held a fish & chip quiz night at the village hall. As a result of the above and continuing annual membership subscriptions, the trustees are very pleased to confirm our net income for the year was substantially above the level of the previous year.

In May 2023 we held another golf day at Hill Barn and preparations are in hand to run a stall at this year's Findon Sheep Fair where we will also be presenting and selling copies of our cookery book with locally provided recipes. Plans are also in hand for this year's Christmas Tree Festival, a 2004 car rally and another quiz night.

The trustees are fully aware of the need to expend the charity's funds in line with its aims as set out in the constitution. Mindful of this the committee continues to engage with the church PCC to identify suitable opportunities to contribute to the cost of repair/refurbishment work. Post the balance sheet date we donated £2,000 towards the recently refurbished church front door and it is likely we will partially cover the cost of replacement guttering and/or roofing to avoid future water penetration to the building.

The trustees would like to extend their grateful appreciation to all members for their continued regular contributions and support generally at the same time welcoming any suggestions for new fund raising events.

Our reserves show a very healthy position although this is not of course our primary function. The charity exists to offer financial support for the care and maintenance of the church and churchyard so that said, we are well placed to offer such support as and when the need arises.

In round terms the profits from our fund raising activities were as follows:

The committee has recently decided to acquire two gazebos for external use at our various outdoor events. The gazebos can be used independently or connected together to provide a larger covered area. These will be expensed as a cost item thereby reducing our income/profits for the forthcoming year with the plus side being their future availability and the opportunity to rent out to other organisations for similar purposes.
